



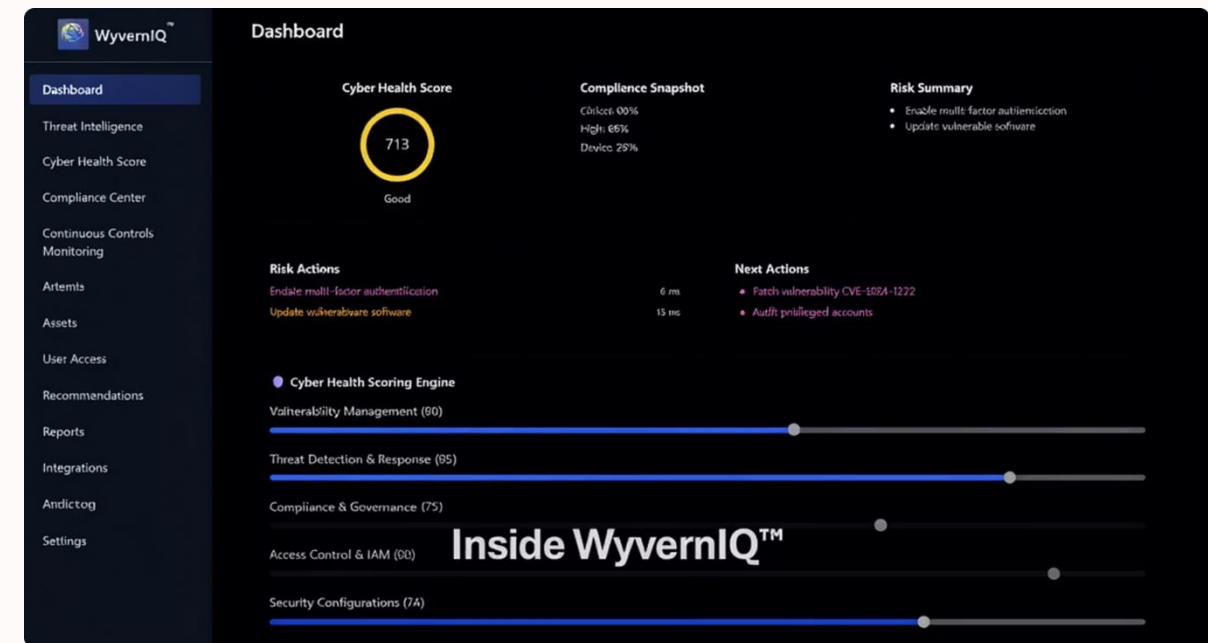

Problem

The Defense Information Systems Agency (DISA) faces the challenge of rapidly onboarding commercial software while ensuring strict compliance with DoD RMF, IL5/IL6 overlays, and the internal ATO process. Traditional methods rely on spreadsheets, static documentation, and fragmented toolsets, which can drag the ATO process out for up to two years. Vendors often struggle to clearly separate inherited controls (provided by DISA services like VDSS, Olympus, CI/CD pipelines, DLP, and network segmentation) from those they must implement themselves. This creates costly delays, redundant work, and incomplete packages—slowing DISA's ability to deliver secure, modern capabilities to the warfighter.
